REDUCED SNAP BENEFITS?

YOU CONTACTED US BECAUSE YOUR SNAP IS GOING DOWN

Since COVID started, SNAP (food assistance) recipients received the maximum monthly benefit for their household, even if they were eligible for less.

This COVID SNAP supplement ended in February 2023. Everyone's SNAP will go down starting March 2023.



Make sure DHS is correctly calculating your SNAP

How do I make sure my family gets the most SNAP benefits we can?

Know how much you are getting.



2 Know what how much SNAP your family should receive.

Ask DHS to fix it if they are giving you less than you are entitled to receive.

THERE ARE FOUR WAYS TO FIND OUT HOW MUCH SNAP YOU ARE RECEIVING:


- Review your Notice of Decision from DHS. If you don't have a recent DHS Notice of Decision with a SNAP budget, find one at Manage My Case. This is the best way to review your benefits because it will tell you what numbers DHS used to calculate your benefit amount.
- Manage My Case: Create a personal DHS account at <u>https://abe.illinois.gov/abe/access/</u>. The "Benefits Details" section will tell you have much SNAP your family currently receives.
- Link Online Portal: See your SNAP balance at <u>https://www.ebtedge.com/gov/portal/PortalHome.do</u>.
- **Call** the number on the back of your link card (1-800-678-5465) and enter your 16 digit link card number.

Use the SNAP Eligibility Calculator at https://fscalc.dhs.illinois.gov/FSCalc/ to find out how much SNAP you should receive. Enter your information and the calculator will tell you your estimated eligible amount.



The next page will show you:

- how to figure out what numbers to use in the calculator,
- how to tell what numbers DHS is using in your Notice of Decision, and
- what you can do to fix it if DHS has it wrong.



If your SNAP is too low, contact DHS and ask them to recalculate your benefits.

There are several ways you can ask DHS to increase your SNAP. You have the right to appeal if they won't increase your benefits.

- Manage My Case: Report changes in your circumstances, such as rent and medical expenses. DHS will use your report to determine your SNAP amount.
- **Phone**: Call your local DHS office. The phone number is on any DHS Notice of Decision.
- **Fax**: Send a fax to your local DHS office. The fax number is on any DHS Notice of Decision.
- In Person: Go to your local or any DHS office to report a change. The address is on any DHS Notice of Decision.

If you are missing at least \$100 a month in SNAP benefits, and live in Cook County, Legal Aid Chicago can help advocate for DHS to increase your benefits.
